- c. **Age :** UPPER AGE LIMIT: 45 years
(Upper age limit is relaxable by 5 Years for SC/ST & 3 Years for OBC Candidates.
Ex- Servicemen will be given age relaxation as per rules).

2. Assistant Crew Controller

- a. **Qualification :** Graduate from Recognized University. Proficiency in using computers.
- b. **Experience :** Minimum 18 months experience as a crew controller in an Airline /CMS/Roster/Training Department. The Experience should be Post Qualification
- c. **Age :** UPPER AGE LIMIT: 45 years

- Graduation Degree .
- Marks sheet of degree
- Experience Certificate from employer (Airline) giving details of 03 years working experience as Crew Controller in an airline CMS/ Roster.
- SC/ST Certificate In case of SC/ST candidates.
- OBC Certificate in the prescribed Performa for Central Govt. Employment issued by the competent authority.
- A Demand Draft for an amount of Rs.1,500/- (Rupees One Thousand five hundred only) payable to Airline Allied Services Limited, payable at New Delhi (Not Applicable for SC/ ST Candidates).
- A duly filled in Application Form in the prescribed format which is available on Career Page of Website:www.airindia.in and a recent passport size photograph pasted in the space provided in the Application Form.

HOW TO APPLY:

- i) **Applicable for SC / ST / OBC Candidates ONLY :** Caste Certificate in the prescribed proforma issued by the appropriate authority. Candidates belonging to OBC Category will be required to attach the Caste Certificate in the proforma meant for Central Government employment." Candidates belonging to OBC category ,the category certificate should be in the prescribed format including the "Non –Creamy layer clause" issued by the Competent Authority for employment under Government of India and should be as per the Central list of OBC's published by Government of India. Please also note that the validity of "Non - Creamy layer" Certificate should not be older than 06 (Six) months from the date of eligibility criteria."
- ii) Applicants serving in Government/Semi-Government/Public Sector Undertakings should apply through proper channel.

FIXED TERM EMPLOYMENT AGREEMENT :
